## Overview

#### Key highlights

- Reported Profit after tax of INR 278 million for the quarter ended June 2018
  - Profitability was majorly impacted by the adverse impact of foreign exchange, high fuel prices and the competitive fare environment
- For Q1 FY19, on time performance was 83.9%, technical dispatch reliability was 99.85%
  and flight cancellation rate was 0.33%
  - Ranked No. 1 in OTP for each of the months of April, May and June
- Added 2 new destinations in the quarter; total number of destinations increased to 52 including 8 international destinations
- Awarded the 'Best Low Cost Airline in Central Asia and India' at the Skytrax World Airline
  Awards 2018 for the ninth time in a row
