The Board of Directors at its meeting held today i.e. Thursday, April 24, 2025, has inter-alia approved/noted the following:

1. Appointment of Mr. Michael G. Whitaker (DIN:02846728) as an Independent Director

Mr. Michael G. Whitaker has been appointed as an additional and Independent Director for a term of five (5) years effective from the date of receipt of security clearance from the Ministry of Civil Aviation (MoCA). The appointment is subject to approval of the shareholders of the Company.
